








## Checklist: Preparation for a Catholic Marriage

### The Most Important Points to Check ✓

-   Responsibility of the minister is given
- Particulars of the couple are fully charged (page 1 above, section A)
-   Baptism(s) is / are proved through documents or oath (number 3 b)
-   Single status for each of the partners is proved through documents, personal oath or personal acquaintance (number 7)
- Impediments to marriage, prohibitions from marriage, and clear intention to marry, are proved (number 11, 13, 14-17)  
⇒ questions 11 and 13: **without entry (otherwise request for dispensation has to be made)**; questions 14-17: **all affirmative**
-   Questions to the Catholic partner in case of marriage with a partner of a different confession / religion or with a partner who has distanced himself / herself from faith are **both affirmative** (number 18)
- Dispensation from banns and / or permission for inter-confessional marriage are granted only under number 24 a and b, when the marriage preparation protocol not for any other reason has to be submitted to the diocesan office (otherwise apply in number 23 a and e)
- All necessary dispensations / marriage permissions / *Nihil obstat* are applied for (section C)
-   In case of request for dispensation a legitimate reason is named (number 23 b, d, f)
-   In case a dispensation from the canonical form of marriage is requested: the place in which the marriage is to be substantiated is to be indicated (possibly with a zip code) (number 23 f)
-   Authority to officiate is given (*ex officio* or delegation) (number 27)
- Marriage license is granted (number 28)
- In case the marriage is to take place out of Germany, *Litterae dimissoriae* carefully filled in and attached
- All documents are signed
- All original documents or certified copies are attached

**Have you checked all the points? If not, then more has to be done, or the marriage cannot take place under circumstances!**

## Checklist: Preparation for a Catholic Marriage

When you have to submit the marriage preparation protocol to the diocesan office

<b>Ask yourself before every marriage:</b>		
<input type="checkbox"/> yes	Is there a difference in religion between both partners? (numbers 3 a, b, 11, 23 b)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Is it a marriage between partners of different confessions whereby one of the partners is Orthodox, or of a different rite? (numbers 3 a, b, 12, 23 e, h)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Should a canonical dispensation from the canonical form of marriage be administered in case of marriage between partners of different confessions or religions? (number 23 f)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Has one of the partners (or both) had a previous marriage?(numbers 8, 23 h)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Is there any impediment to marriage for any of the partners? (numbers 11, 23 d)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Has any of the partners (or both) a prohibition to marriage? (numbers 13, 23 g)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Is the marriage ceremony scheduled to take place abroad? (numbers 23 h, 28)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Is there another reason to request for a <i>Nihil obstat</i> ? (number 23 h)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Is the marriage to take place outside a church (outdoor, etc.)? (can. 1118 § 2 CIC)	no <input type="checkbox"/>
<input type="checkbox"/> yes	Are there any other problems (doubts about the marriage will or lack of prescribed documents, etc.)?	no <input type="checkbox"/>
<p><b>x</b> If <b>even one</b> of these questions has been answered with "yes", you must submit the marriage preparation protocol to the diocesan office. If you do not submit the protocol to the diocesan office, and nevertheless carry out the ceremony, such a marriage may be <b>invalid</b>.</p> <p>In case of an existing previous marriage, <b>do not in any case commit yourself to fixing a wedding date.</b></p>	<p><b>✓</b> Only when all these questions are answered with "no" then you can go ahead to perform the ceremony, without first forwarding the marriage preparation protocol to the diocesan office.</p>
